Dear Marcus, Mayor Barnett, and Cadillac City Council:

The Clam Lake Township Downtown Development Authority (CLTDDA) is asking for the City of Cadillac's position regarding the draft CLTDDA sewer service agreement that was in the final stage of approval as of April 18, 2013. It is our understanding that the agreement we have been negotiating in good faith for many months is now being tied to the annexation of the M-55, US-131 property. Clarification of this issue is being requested in writing because the reported annexation requirement runs contrary to the general principles of the agreement reached several months ago with city officials. CLTDDA is requesting this information be provided in writing on or before June 4, 2013.

Please note that the CLTDDA board is ready to move forward in order to find an equitable outcome for all parties.
